Delay of payment shall entitle the Seller to claim default interest at a rate of 12 % p.a., and without further conditions as well as in the case of the Buyer failing to meet collection date according to article four, the Seller is entitled to withdraw from contract. If contract is cancelled by any circumstances induced by the Buyer, the Seller shall be entitled to claim in compensation from the Buyer a 10% cancellation fee of the total purchase price and / or compensation for the actual loss incurred.

4. Transfer / Collection

At the time of unsuccessful expiration of collection date or in the case of delivery and collection of the vehicle respectively, at this set date at the latest all burden and risk connected with the possession of the vehicle shall pass on to the Buyer. The Seller is not liable to any damage or loss after collection date has expired fruitlessly (e. g. theft), unless Seller is to be held responsible for this incident by wilful and wanton negligent conduct. In the case that the motor vehicle is not collected in due time, the Seller shall be entitled to charge reasonable stall money (= 10 EUR per day).

5. Reservation of Title

The Seller preserves title of delivery item until payment had been made in full, including ancillary expenses. The Buyer is not authorized to dispose of the vehicle that is subject to reservation of title. In particular, the Buyer is not authorized to resell the vehicle!

6. Ancillary Verbal Agreements

Any alteration of this contract shall be carried out in written form (see to article nine). Verbal ancillary agreements are not legally effective.

7. Warranty

The purchase shall take place without covenant regarding actual properties, current KM-mileage, current condition (vehicle road safety and operating reliability) and market value. The Buyer has closely inspected, checked und test driven the vehicle (or could have done so) and explicitly waives any warranty, including any hidden defects.

8. Place of Performance / Place of Jurisdiction

It shall be deemed to have been agreed upon: Place of Performance, Place of Delivery and Place of Jurisdiction: 8330 Feldbach. Austrian Law is to be applied.
